## **Job Summary**

The Child Care Assistant, under the direction of the Director of Children's Programs will work as a full member of the Mothercraft Ottawa Daycare team.

The Child Care Assistant will assist the Program Team in delivering high quality child care and summer programming to the children enrolled in the Mothercraft Ottawa Daycare programs. The Child Care Assistant will work with team members in a broad range of roles, working in programs with children ranging in age from 6 weeks to 6 years.

The Child Care Assistant is responsible in assisting the Lead Educators, Early Childhood Educators and Educators in providing diverse basic care needs including supplying proper nutrition and performing cleaning duties.

As early as April 23, 2019 depending on funding

This position is conditional on successful funding from the Canada Summer Jobs program. Dependent on funding, the position will be for 30-40h/week for 6-16 weeks in total. Interested candidates are asked to apply by April 5, 2019, with interviews to be scheduled thereafter. No official job offer can be made until the Canada Summer Jobs funding has been announced.
