Time Commitment

Directors are elected for a 3 year term, which is renewable. We understand that each person's life situation can change, but we do ask that Directors prepare to commit for at least 3 years.

The Board meets approximately 6 times a year, either in-person (in Westboro) or virtually (Microsoft Teams). Board meetings are typically 2 hours, and take place in the evening.

Each Board member is expected to participate on one of the Board's Committees (current committees: Finance, Personnel, and Strategy). Committee meetings are held virtually, approximately 3-4 times a year, and are typically 1 hour.

The overall time commitment for a Board member is approximately 3-5 hours per month.
